- 1. Previous Minutes Approved as presented.
- 2. Paymaster Report Darlene presented an up to date Paymaster Report which approved unanimously. She reported that AEDs are good for 2019 and both regions have awards enough on hand for the year, so expenses this year should be down. The Wisconsin Region will have to order awards next year.
